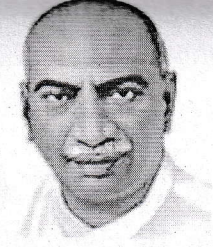

She should complete the course work **within one year from the date of registration** as mentioned under provision 6 of the Ph.D. regulations in force and circular dt. 25.08.2020. The candidates with M.Phil., degree in the relevant fields of research are exempted from the Research Methodology paper provided they have secured 55% and above in Research Methodology of M.Phil. program. She should submit the thesis **not earlier than Three years and not later than Six years from the date of Registration**. She should pay the fee as per the details given below:

A Research Advisory Committee should be formed for each candidate with an external subject expert nominated by the Vice-Chancellor from among the panel suggested by the Supervisor to monitor the progress as stipulated in the Ph.D. regulations (Division 14) of Madurai Kamaraj University.

candidate should publish atleast 2 (two) research papers relevant to the area of research as first author in National/ International journals as listed by the UGC for submission of the Ph.D. thesis, following the amendments implemented from 24.05.2019.

The fee should be paid on the given registration date of every year within 30 days. A grace period of one month may be availed by the candidate by paying a penal fee of Rs.500/-. If the fee is not paid even after this period, the registration shall stand cancelled automatically.

All fees shall be remitted through the link available in the portal (<http://rsm.mkuniversity.ac.in>).
