A Research Advisory Committee should be formed for each candidate with an external subject expert nominated by the Vice-Chancellor from among the panel suggested by the Supervisor to monitor the progress as stipulated in the of Ph.D. regulations (Provision 6.4) of Madurai Kamaraj University. The candidate should publish atleast 2 (two) research papers relevant to the area of research as first author in National/ International journals as listed by the UGC for submission of the Ph.D. thesis, following the amendments implemented from 24.05.2019.

The fee should be paid on the given registration date of every year within 30 days. A grace period of one month may be availed by the candidate by paying a penal fee of Rs.500/-. If the fee is not paid even after this period, the registration shall stand cancelled automatically.

All fees shall be remitted through the link available in the portal (<http://rsm.mkuniversity.ac.in>).
